South London Business to manage Deptford New Cross Renaissance

We are pleased to confirm that we have been asked by the London Development Agency to manage the "Deptford New Cross Renaissance" City Growth Project. The project's aims are similar to those of the "Heart of South London" City Growth initiative that South London Business was awarded in April 2004. David Main said "I am delighted the LDA has asked us to manage this project. The aim is to develop a long-term strategy to realise the economic potential of an area that has not enjoyed the prosperity it deserves. We are determined to develop a coherent strategy for Deptford New Cross that will benefit both the local business and residential communities and support the LDA's confidence in South London Business". The initiative area includes Deptford and Lewisham Town Centres and is a part of the nation-wide City Growth initiative driven by the Government's commitment to address deprivation of urban areas through the growth of private enterprise. Like the "Heart of South London" bid, this programme is based on an innovative cluster-regeneration model, developed in the US, that puts business at the heart of regeneration, bringing to life the competitive and economic potential of deprived areas.

The Deptford/New Cross Renaissance project will begin in July 2004, is due for completion in March 2006 and is funded by the LDA. Deptford/New Cross Renaissance will be delivered in partnership with the LDA through private and public sector partners from the Deptford/New Cross area, led by South London Business.
